**APPLICATION FOR TRANSPORTATION TO A NON-PUBLIC SCHOOL  
2018-2019**

This application for school bus transportation to a non-public school for 2018-2019 must be submitted by **April 1, 2018**. New residents have 30 days from establishing residency to submit an application. A separate form must be completed for each student, and a new application must be submitted for each school year. *If you have not yet confirmed your child's acceptance at the school, you should still submit an application by the April 1 deadline in order to be approved for busing. If you are considering more than one school, you should submit a form for each school and then notify the transportation office of your final decision.*

There are no exceptions to this law. The District requires proof of age for all children entering kindergarten (please attach a copy of the child's birth certificate or bring it to the District office for verification). Be advised that transportation is not provided for orientation days, after-school activities, or on Federal holidays. Please see district website for further information.
